① The committee takes pleasure in declaring that all the three bidders namely Ideal Solutions, Guwahati Industrial Art and Verma Sports bidding for the work 'Supply of Sports Items' have qualified their Technical bids. The 'Financial bids' of the said bidders are opened in presence of the RUSA members and bidders present and the rates quoted are communicated to all.

Daulak could not qualify the Technical Bid on the ground that the validity of his registration as a contractor expired on 31st March 2018.
