<u>REPORT FOR SKILL BASED COURSE UNDER NSQF</u> <u>DIPLOMA IN SATTRIYA DANCE AS A PERFORMING ART FORM</u>

Dr. B.K.B College has introduced Sattriya Dance as a subject in the Three Year Degree Course, the first initiative under Guwahati University in the domain of performing arts and has got overwhelming response since inception. But there are some more aspiring learners being engaged in other fields who would like to pursue a Diploma Course in the Subject for a prospective career in dance, acting, cinematic production, tourist industry etc. Besides, some of the students pursuing three year degree course would like to complete a certificate course on Sattriya Dance which might help them to plan for self-employment.

"Diploma in Sattriya dance as a Performing Arts form" started in February, 2021 with 13 students and one Permanent Faculty with a view to provide platform for potential students who excelled in dance. It has been introduced as per norms followed by NSQF for the year 2020-21. Infrastructure, practical room, musical instruments and other facilities are available at the college.
